Senders should determine import restrictions from Yemen authorities before posting: 1. Animal products 2. Alcoholic beverages 3.

In addition to items prohibited by Dangerous and Prohibited Goods & Packaging Post Guide and ECI International Courier.

Each parcel or each group of parcels dispatched simultaneously by a single sender to the same addressee requires a commercial invoice. The sender and receiver details must.




