Can lithium batteries for energy storage be transported by air



Overview

ICAO bans the carriage of lithium-ion batteries as cargo on passenger aircraft. ICAO recommends that hoverboards be carried as carry-on baggage. Can a lithium battery be transported by air?

Devices with lithium batteries exceeding the above specifications cannot be transported by air but can be carried by road or over sea. These restrictions do not apply to older devices powered by nickel-cadmium (NiCad) and nickel-metal hybrid (NiMH) batteries. Batteries of any kind must always be transported and shipped inside the device.

Can I ship lithium batteries by airmail?

You will need to contact your local postal authority to see if you be able to ship them by surface methods i.e. sea, road and rail. If you have to send the lithium batteries by air, then you will need to send them with a freight company. Can a lithium battery be shipped alone?

You can still ship stand-alone lithium batteries if they comply with either Section IA or IB of the IATA Dangerous Goods Regulations (DGR) packing instructions 965 and 968, which are fully regulated dangerous goods shipments that require the Shipper's Declaration for Dangerous Goods be completed and signed by a trained shipper.

Can a battery be transported by air?

Defective or waste batteries are forbidden for transport by air (Special Provision 154). Each cell or battery must be of the type proven to meet the requirements of UN Manual of Test and Criteria Part III Sub-Section 38.3. NO.

How to safely transport lithium batteries?

Selecting suitable packaging, and then packing the batteries safely, is a key component to safely transporting lithium batteries. For larger batteries, the packaging may need to UN specifications. What type packaging you need is not a “one size fits all” answer.






