# **Dublin New Energy Storage Support Requirements**

What is the electricity storage policy framework for Ireland?

In line with CAP Action EL/24/16, the Electricity Storage Policy Framework for Ireland (ESPF) was published by my Department in July 2024. The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition.

What is Ireland's energy transition policy framework?

The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition. Actions #6 to #10 of the policy framework are designed to stimulate the development of the optimum level of electricity storage systems, including Long Duration Electricity Storage on to the grid network by 2040.

Will Ireland be a business-friendly market for energy storage?

The publication of the Electricity Storage Policy Framework sends a clear and positive signal to potential developers and funders that Ireland intends to be a business-friendly market for energy storage, writes Seanna Mulrean, Consultant and Head of Energy and Natural Resources at LK Shields.

What are the future plans for electricity storage?

Two memos setting out future plans for development of electricity storage, which will allow excess renewables to be stored and used when needed, and for private wires have been approved by Cabinet. The latter will allow community energy groups, private individuals or other energy users to run their own electricity cables to transfer electricity.

What is Ireland's energy policy?

The policy is a practical initiative in Ireland's energy strategy and is designed to advance the integration of ESS into the grid network. By addressing key areas such as market access, technical standards, and funding mechanisms,

the Policy aims to provide a realistic framework for achieving Ireland's renewable energy targets.

When will optimum electricity storage requirements be identified?

A route to market for the identified optimum (long duration) electricity storage requirements for 2030-2040 is to be in place before the end of 2028.




