Zambia household energy storage standards requirements



Overview

How is energy storage regulated in Zambia?

In Zambia, the legal and regulatory framework for energy storage, including renewable energy storage, is primarily governed by the Energy Regulation Act No 12 of 2019 and the Electricity Act No 11 of 2019. These Acts establish the ERB as the primary regulator, responsible for licensing and setting standards for energy storage activities.

Why did Zambia implement new electricity (open access) regulations in 2024?

Zambia implemented new Electricity (Open Access) Regulations in 2024 to promote a more competitive and sustainable energy market. These regulations aim to address challenges arising from the country's heavy reliance on hydropower and a surge in private investment in the energy sector.

How to sell renewable power in Zambia?

The legal and regulatory framework for utility-scale renewable power sales in Zambia is governed by the Energy Regulation Act No 12 of 2019 and relevant ERB regulations. Developers must obtain a generation licence from the ERB to produce and sell electricity from renewable sources.

What is the energy sector in Zambia?

The energy sector in Zambia operates primarily under Energy Regulation Act No. 12 of 2019 (Energy Act), which broadly defines “energy” to include various sources such as electrical, mechanical, thermal, or chemical power derived from sources like electricity, petroleum, coal, renewable sources, and others as determined by the Minister.

Are microgrids allowed in Zambia?

Microgrids are permitted to operate in Zambia under the regulatory oversight of the ERB, as outlined in the Electricity Act No 11 of 2019 as well as the

Energy Regulation Act No 12 of 2019 together with relevant regulations.

How many people have access to electricity in Zambia?

Access to electricity in Zambia requires substantial efforts to achieve normal electrification rates. Only 70.6% of people living in urban areas have access to electricity, a figure that drops to only 8.1% for rural areas. No data is available on home appliances and energy consumption patterns for home appliances in Zambia.
